


YML Innovation Contest Made at home 3D Printing

Contest Rules





Manufacturing





Design and print an item which have a practical or decorative application in the everyday lives, whether at home or in the office.

The entries will be judged based on the design of the object and the use of 3D printing technology.

A 2-minute video presentation (in English) should accompany the entry. The video must describe the idea behind your design, its printing, along with its decorative and / or functional applications. The video will be also evaluated.

The overall aim is to have fun with the design of an interesting and useful object, part or gizmo, and to promote manufacturing and technical thinking in general.







Contest rules

The call is open until 20/09/2021 at 11:59 PM CEST.

Applicants must be members of the <u>YML</u> <u>network</u> (registration is open to those between 18- and 30-year-old).

The Design must be submitted in the form of stl file.

The 2-minute-video presenting the design and its application must be in English

The idea can be developed by a single YML member or by a team of up to 3 persons. Note in the case of the latter the prize will be shared.

You can come with your own product, interesting redesign of existing product or specific application.

The innovative components must be fabricated by 3D printing .

The goal is to have fun and promote manufacturing and technical education in general.

Evaluation criteria



The ideas will be evaluated by CVUT Prague, project partner of YML TWO.

Originality 30%

This criteria is focused on idea originality. You can create your own product or modify one that is currently in use in the home or office, for example. The competition committee will base their assessment on the creativity of the idea and the uniqueness of the solution.

Usefulness 30%

This criteria considers the application potential of the developed part. The following aspects will be evaluated:

- Decorative appeal
- Application benefits
- Production cost/benefit analysis
- Value for the end user

Video presentation 40%

Provide some background of the idea, along with how it was designed and developed, as well as its decorative and / or application benefits. Briefly explain the uniqueness / innovative nature of the 3D printed part. The video should be suitable for a general audience – consider issues such as production, image and sound.

Video file formats: MP4, WMV, AVI

Video resolution: 1080p

Duration: maximum of 2 minutes

Purpose of the personal data processing: the personal data of the Data Subject will be processed for the purposes connected and instrumental to the activities explained in the previous release and will be disseminated according to the methods equally described in the release. Personal data will also be processed to the extent that processing is necessary for obtaining consent in relation to this document and for the storage / archiving of the same.
